NOTIFICATION

Related to admission in UG Courses (including Vocational) at Constituent and Affiliated Colleges of BBMKU (Session 2020-23)

The process of Admission and Registration to regular B.A./B.Sc./B.Com. courses and UG vocational courses (BBA/BCA/B.Sc. Biotechnology/B.Sc. Environmental Science) at Constituent, Affiliated and Minoritycolleges of BBMKU will be completed through Chancellor Portal (https://jharkhanduniversities.nic.in) only. The application process has commenced on the portal on 29th July 2020. The last date of application has been extended up to 28th August 2020, which will not be further extended for regular courses in Constituent colleges in any case.

The process of admission will be conducted in the following manner:

1. Selection List and Approval by University:

- (i) The first selection list for constituent colleges and merit list for affiliated colleges will be released by University Admission Cell on 3rd September 2020.
- (ii) University will approve the name of the applicants figuring in the selection/merit list through its login on Chancellor Portal.

2. Document Verification and Approval by College:

- (i) Because of the COVID-19 scenario, the physical verification of documents is not possible at this stage and this should be done at the earliest possible opportunity when colleges resume normally.
- (ii) Colleges must take an Undertaking from each selected applicant in the prescribed format (as attached) which should be duly signed by applicants and his/her parent/guardian.
- (iii) The undertaking need to be collected electronically for which colleges should publish relevant email addresses on its website or make an arrangement for its upload on the website.
- (iv) The college will Approve the Provisional Admission to all those applicants whose undertaking has been received within the specified period of validity of the selection/merit list.
- (v) This approval for provisional admission has to be done on the Chancellor Portal through College login.
- (vi) For student approval at college end, each college will be provided with their User Id and Password for Chancellor Portal. Principals are supposed to keep it confidential.

3. Collection of Admission Fee:

- (i) As soon as an applicant's name is approved by the college on the Chancellor Portal, the admission fee payment link gets activated in his/her login at the portal.
- (ii) The approved applicants will have to pay the admission fee online through the payment gateway integrated at the Chancellor portal.

(iii) For Constituent colleges, the complete admission fee is mapped at the chancellor portal. The complete admission fee for regular courses, payable at chancellor portal will be as given below:

(iv) For Affiliated colleges, an applicant has to pay a partial admission fee (University Components) through Chancellor Portal. The partial admission fee payable at chancellor portal will be as given below:

(v) Affiliated colleges will have to collect the remaining portion of the admission fee preferably online/UPI. Offline collection of the remaining fee should be done only after college resumes normally.

4. Registration:

(i) The process of Registration will be through the Chancellor portal only.

- (ii) Registration will be allowed to only those applicants who have deposited the admission fee (full or University component as applicable) on Chancellor Portal within the specified period.
- (iii) It should be noted that Only Provisional Admissions are being allowed before the physical verification and collection of required documents based on the undertaking. The registration will be allowed to only those applicants whose documents are found in order at the time of physical verification.

5. Cancelation of Provisional Admission:

- (i) All the admissions offered at this stage are provisional and will be finalised for registration only after the required documents are physically verified and found in order.
- (ii) If during physical verification documents of any applicant is not found in order or different than the information provided in the application form then his/her provisional admission will be immediately cancelled. No extra time will be given to produce the required documents and no further communication will be entertained in this regard.
- (iii) If any case of production of false claims based on forged documents is detected at any stage then legal action will be taken by the College/University against the student producing so.

6. Commencement of Online Class:

The above-mentioned procedure of provisional admission is adopted to start the online classes of the new academic session at the earliest. Given this, the Online Classes of UG session 2020-23 will begin on **Monday**, **21 September 2020**.
